# **Material Facilities**

<u>The Environmental Permitting (England and Wales) (Amendment) Regulations 2023</u> (legislation.gov.uk) was made on 27 October 2023 – amendments will apply from **1** October 2024.

These amended regulations will enhance the quantity and quality of waste data, especially packaging data, which will underpin tonnage and quality related payment mechanisms that will be used within the Packaging EPR scheme.

The amending SI and associated guidance set out the requirements in England and Wales.

Further guidance on the amended regulations has now been published on Gov.uk – Materials facilities waste sampling and reporting from October 2024

# **Digital Waste Tracking**

## The baseline journey for UK waste movements

- · General process flow for the recording of waste movements.
- Following scenario shows users entering records directly on the web service.
- We are also designing ways to upload information in bulk through CSV uploads (spreadsheets) and APIs.
- We are currently developing a digital design to also incorporate regular movements of waste of the same type from the same producer, so that the initial details will only need to be entered once (reviewed at least annually). This includes considering the context of specific sectors such as healthcare waste, the construction/demolition waste sector and for LA statutory waste collections where appropriate.

# The baseline journey for UK waste movements

- Multiple collections we are designing how records relating to waste from different producers collected on one vehicle can be linked so that waste receiving sites can enter their confirmation of receipt of the total volume of waste just once.
- Flexibility we understand that there is a need for flexibility and to accommodate times when collections may change, waste sites are unable to accept waste or waste haulage is sub-contracted etc.
- We are aware of sensitivity around upstream visibility of producer's details.





#### COLLECTION CONFIRMATION ON WTS



The manager at the carrier signs in to the WTS web-app via Gov Gateway The manager at the carrier navigates to the relevant digital waste record and provides confirmation that the waste was collected by their driver.



#### RECEIPT OF WASTE ON WTS



Manager at receiving site signs in to the WTS via Gov Gateway Manager at receiving site navigates to the relevant waste record and confirms receipt of the waste Producer receives code from carrier that they can use to check the fate of their waste

Sometime after waste movement...

CHECK ON FATE OF WASTE



The producer receives an email from the manager at the carrier, containing a unique ID they can use to see the fate of their waste, and a URL to visit to do so.

The producer clicks on the URL in the email and then enters their unique ID to see the fate of their waste!

# Responsibilities

- It will be the responsibility of the person arranging a waste movement to generate the waste tracking record. This reflects what often happens now in practice i.e. the broker/carrier producing the paperwork.
- **Producer responsibility** the producer will remain responsible for providing the waste contractor with an accurate description of their waste.
- Signatures we do not intend to include functionality to capture signatures.
- Misclassification where a waste receiving site finds that waste has either been incorrectly classified or there is non-conforming waste hidden in a load then there will be functionality in the service to note this on the relevant record and indicate what action is to be taken. If the operator is content that they are authorised to accept the waste under the correct classification, then they will be able to record the new classification.

## Responsibilities

 We intend to include a new legal requirement for people to retain documentation regarding waste classification as part of the waste tracking regulations.





# Defra Fellowship scheme supporting Resources & Waste, the UK, EU and UNECE region

- Commitments in the RWS
  - Double in resource productivity by 2050
  - Can help us move towards zero avoidable waste by 2050
  - Can help us move towards zero avoidable plastic waste by 2042
  - Eliminate waste crime and high risk illegal waste sites by 2042
  - Can demonstrably reduce littering and littering behaviour in a generation.
- UK challenges are also EU & UNECE challenges: The same legislation 'the waste framework directive'.
- Appointment of 6 fellows to support delivery of a Circular Economy Data Observatory.
  - Data collection critical.
    - · Waste is a business, if business can see a waste feedstock they will capitalise, rPET, paper/card, glass
    - Data allows us to model the impact of policy tools prior to introduction, plastic tax, EPR (paper, card, glass)
    - Data allows us to measure the success of policy: pre policy then post policy introduction
    - Solutions for the UK waste environments directly transposable to the EU and UNECE regions.
    - Waste companies operating in the UK also operate across the UNECE region











# **Update on Local Authority Payments**

- First component of LAPs on track to be tested by authorities in late Spring 2024
- This component onboards the first three key players from each Local Authority: Chief Executive, Head of Waste and Head of Finance
- We intend to invite all ~120 LAs across the four nations that have expressed an interest in participating in private beta testing to test this first component
- Will take a staged approach to inviting Chief Executives to register
- No commercial advantage to being in an earlier group
- At this stage, feedback will be collected via LAPs rather than in interviews.





# Report Packaging Data – What do producers need to do?

- Large producers must report their packaging data to the regulator by creating an account on the new Report Packaging Data (RPD) online service via gov.uk and enrolling as a producer.
- Large producers must report both their packaging data and their organisational details by submitting csv files to the regulator using their RPD account.
- Data submissions are required for January to June, and July to December. If you don't have all the data from January to June, you can report data from March to June instead.
- In 2023, obligated producers in Wales do not have to report data from January to June, but may choose to report that data if they wish.
- <u>This report is in addition to the normal report that was due into NPWD</u> by 7<sup>th</sup> April

# **Report Packaging Data – 2023 data reporting update**

- To date, there are **5929** enrolments on RPD from large producers, but:
  - Only **2145** producers have submitted their packaging data;
  - Only **1956** producers have submitted their organisational details.
- A regulatory Position Statement has set out that no enforcement action will be taken about late submission if your data is submitted by 31<sup>st</sup> May 2024.
- You should still make your best efforts to submit your data as soon as possible – this will help us accurately calculate fees and disposal costs.



# Labelling

Mandatory EPR labelling will be required on packaging placed on the market from 1 April 2027


